1. Publish the notice if the levy (ask) will be more than 5% over the prior year's







- Continued emphasis on Chronic Absenteeism
  - 45.3% students in 2023-2024

Illinois law defines “chronic absentee” as a student who misses 10 percent of school days within an academic year with or without a valid excuse. That’s 18 days of an average 180-day school year. Excused absences include illness, suspension, need to care for a family member, etc. Students need daily instruction in order to succeed. Chronic absentees are at risk of academic and social problems.

<b>District Highlights</b>	<p>Superintendent Clark read a proclamation regarding School Board Members’ roles, duties and responsibilities as a member of a governing body and thanked the Board of Education for their hard work as we prepared to celebrate School Board Member’s Day on November 15, 2024.</p> <p>Heather England, Principal of Franklin Grove Elementary School, and others presented and shared information regarding their family events and community supports.</p>	Information only.
<b>Public Participation</b>	<p>President Clevenger noted that during Public Participation, the Board of Education asked for the following:</p> <ul style="list-style-type: none"> <li>● Identify oneself and be brief.</li> <li>● Comments should be limited to 3 minutes.</li> <li>● Any public comments submitted to the Board Secretary will be included in the record.</li> </ul> <p>For our listening audience, please note that during any Board of Education meeting and public participation, Board Members do NOT respond and/or comment to public comments; all comments are referred to administration. Furthermore, the Board refrains from referring to specific students or staff members by name, and requests that public commenters refrain from doing so as well. The request that you omit names was made to protect you from allegations of libel or slander or from violations of the Illinois School Student Records Act. It was not intended to shield an employee from criticism.</p> <p>Ashlee Smith, DEA Leadership, spoke to the Board Members regarding teacher shortages and its impact in special education and district-wide; additional duties were being picked-up by other staff members. She asked for the Board to consider a better way of staffing the classrooms; some are leaving the district and/or leaving education all together. There was a great need for highly-qualified licensed teachers.</p> <p>Chris Shugart, DEA Leadership, spoke to the Board Members regarding teacher shortages and its recruitment efforts. The teacher vacancy rate was 12% and amongst the highest in IL. This was an unsustainable reality. How are we closing the gap? Students were suffering as critical positions were vacant. This demands immediate action.</p>	Information only.

Levy Update

There were four different Levy options for consideration:

- Option A: Builds the levy on \$890M plus Old Towne TIF \$14.6M = \$904,717,455
- Option B: Builds the levy on \$890,029,120
- Option C: Same as Option B but incorporates .04 reduction into an .04 increase to Tort.
- Option D: Same as Option A but incorporates .06 reduction into an .04 increase to Tort.

The rationale for Options C and D was that these funds have not been increased for the past 5+ years. Costs continue to rise. Every year these three funds are manipulated to support the fund with the lowest Fund balance.

Recommendations

- Option D
- If we get confirmation that the Old Towne TIF EAV has not yet been added to the current EAV.
- This allows for an increase in funds that have been status-quo for the last 5+ years.
- This also reduces the rate by approx. 2c – which is what the BOE did last year.
- If it turns out that the EAV is closer to \$890M then, we may consider Option C.
- Option C is under (but very close) to the same tax rate as last year. Dr. Curry would continue to watch for any significant drops in the EAV prior to posting date and adjust the increase in F80 down accordingly to prevent an increase in the rate.

The consensus from the Board of Education was for administration to proceed with Option D, but if the 14.6 was not coming, he will move to Option C.

Mr. Scheider noted that IL (ISBE) has a special education tuition waiver. If you receive a special education certified teaching degree and sign a contract for two-years at an IL public school, all four-years of tuition would be paid in full.

**ASSISTANT SUPERINTENDENT OF SUPPORT SERVICES CONTRACT**  
**Fiscal Year 2025-2027**

This Contract made between the Board of Education of Decatur Public School District No.61, Decatur, Illinois (hereinafter “the Board”) and **Eldon Conn**, (hereinafter “the Assistant Superintendent of Support Services”), ratified at the meeting of the Board held on December 10, 2024 as found in the minutes of that meeting.

**IT IS AGREED:**

**1. Employment.** The Assistant Superintendent of Support Services is hereby hired and retained for the extended contract term of July 1, 2025 to June 30, 2027, as the Assistant Superintendent of Support Services for the District.

**2. Duties.** The duties and responsibilities of the Assistant Superintendent of Support Services shall be all those duties incident to the office of the Assistant Superintendent of Support Services as set forth in the job description, a copy of which can be found in the employee’s personnel file; those obligations imposed by the law of the State of Illinois upon the Assistant Superintendent of Support Services; and to perform such other duties normally performed by the Assistant Superintendent of Support Services as from time to time may be assigned to the Assistant Superintendent of Support Services by the Superintendent of Schools, Assistant Superintendent(s) or the Board. The work day, work year, contract year and holidays and holiday pay for the Assistant Superintendent of Support Services shall be as provided in the document entitled Administrator and Administrative Support Staff Compensation and Benefits (October 8, 2024).

**3. Salary.** The Board shall set the Assistant Superintendent’s salary. For the 2025-2026 fiscal year the amount of the Superintendent’s salary shall be set by the Board but shall not be less than **One Hundred Seventy-Six Thousand Two Hundred Thirty-Five Dollars and no/100 (\$176,235.00)**. The Assistant Superintendent of Support Services hereby agrees to devote such time, skill, labor and attention to his employment during the term of this Contract, except as otherwise provided in this Contract, and to perform faithfully the duties of the Assistant Superintendent of Support Services for the school district and the Board as set forth in this Contract. The annual salary shall be paid in substantially equal installments in accordance with the policy of the Board governing payment of salary to other licensed members of the professional staff. Any adjustment in salary made during the life of this Contract shall be in the form of a Board approved amendment and shall become a part of this Contract. It is provided, however, that by so doing, it shall not be considered that the Board has entered into a new Contract with the Assistant Superintendent of Support Services, nor that the termination date of this Contract has been in any way extended, unless so stated in the Board approved amendment.

**4. Pension.** In addition to the salary of the Assistant Superintendent of Support Services as set forth hereinabove in paragraph 3, the Board shall pay 9.8901% of the salary set forth in paragraph 3 (or 9% deducted from the resulting gross. The resulting gross shall be computed by adding the salary in paragraph 3 to 9.8901% of the salary paragraph 3) as an employer paid pension contribution consistent with the provisions of Internal Revenue Code section 414-h(2) and Tax Opinions 81-35 and 81-36. Such payments shall be consideration for this contract,

shall be creditable earnings for purposes of Teacher Retirement System pension calculations and the Assistant Superintendent of Support Services did not have the option of choosing to receive such amount directly instead of having such contribution paid by the employer to the Teacher Retirement System of the State of Illinois.

**5. T.H.I.S.** From and out of the salary and pension payments of the Assistant Superintendent of Support Services as set forth hereinabove in paragraphs 3 and 4 the Board shall withhold any such amount as may be required by law, on behalf of the Assistant Superintendent of Support Services to the Teacher Health Insurance Security Fund.

**6. Performance Provisions.** This contract is a performance-based contract linked to student performance and academic improvement of the Assistant Superintendent of Support Services pursuant to 105 ILCS 5/10-23.8a. The Assistant Superintendent of Support Services shall meet the goals during the term of this Contract. The parties agree the goals and indicators are linked to student performance and academic improvement of the District. In addition to goals set forth in Appendix A hereto, the Assistant Superintendent of Support Services shall meet the obligations, goals, and requirements set forth in the Assistant Superintendent of Support Services' job description for the position. In consideration for performance pursuant to a multi-year agreement, the Assistant Superintendent of Support Services waives acquisition of tenure during the term of this contract.

**7. Evaluation.** Annually, but no later than March 1st of each year, the Superintendent or designee shall review with the Assistant Superintendent of Support Services' progress toward established goals and working relationships among the Superintendent, the District leadership team, other administrative personnel, the faculty, the staff and the community, and shall consider the Assistant Superintendent of Support Services' annual salary for the next subsequent year (if any). A summary of the evaluation will be provided to the Assistant Superintendent of Support Services in writing within 30 days following the evaluation, pursuant to the District's evaluation plan for Administrators.

**8. License.** The Assistant Superintendent of Support Services shall furnish to the Board during the term of this Contract, a valid and appropriate license to act as the Assistant Superintendent of Support Services in accordance with the laws of the State of Illinois and as directed by the Board.

**9. Other Work.** Permission will be granted in advance by the Superintendent. The Assistant Superintendent of Support Services may undertake consultative work, speaking engagements, writing, lecturing, college or university teaching, and other professional duties and obligations provided that these activities do not interfere with the effective performance of job duties. The Assistant Superintendent of Support Services shall have the responsibility to discuss with the Superintendent and mutually agree to such outside activity in a timely fashion.

**10. Discharge for Good Cause.** Throughout the term of this Contract, the Assistant Superintendent of Support Services shall be subject to discharge for good cause provided, however, that the Board shall not arbitrarily or capriciously call for dismissal and that the Assistant Superintendent of Support Services shall have the right to service of written charges, notice of hearing and a hearing before the Board. If the Assistant Superintendent of Support Services

chooses to be accompanied by counsel at such a hearing, all such personal expenses shall be paid by the Assistant Superintendent of Support Services. Failure to comply with the terms and conditions of this Contract shall also be sufficient cause for purposes of discharge as provided in this Contract.

**11. Termination by Contract.** During the term of this Contract, the Board and the Assistant Superintendent of Support Services may mutually agree, in writing, to terminate this Contract. The termination, reassignment and/or reclassification at the end of the term of this Contract shall be as provided by law.

**12. Referrals to the Assistant Superintendent of Support Services.** The Board collectively and individually and the Superintendent shall promptly refer all criticisms, complaints, and suggestions called to its/their attention to the Assistant Superintendent of Support Services for study and recommendation.

**13. Professional Activities.** The Assistant Superintendent of Support Services shall be encouraged to attend appropriate professional meetings at the local, state, and national levels. Within budget constraints, such costs of attendance shall be paid by the Board upon receipt of a full, itemized account of such costs.

**14. Reimbursement for Use of Personal Car.** The Board shall pay the Internal Revenue Service rate to the Assistant Superintendent of Support Services for vouchered reimbursable mileage expenses incurred by the Assistant Superintendent of Support Services while using the Assistant Superintendent of Support Services' personal vehicle for the conduct of approved District business. Reimbursement shall be pursuant to the District's policies, rules and regulations.

**15. Membership Dues.** The Board shall pay the cost of the Assistant Superintendent of Support Services' annual membership dues as provided in the document entitled Administrator and Administrative Support Staff Compensation and Benefits (October 8, 2024).

**16. Medical Insurance.** The Assistant Superintendent of Support Services shall be provided with medical insurance and medical insurance options as provided in the document entitled Administrator and Administrative Support Staff Compensation and Benefits (October 8, 2024).

**17. Life Insurance.** The Assistant Superintendent of Support Services shall be provided with life insurance as provided in the document entitled Administrator and Administrative Support Staff Compensation and Benefits (October 8, 2024).

**18. Vacation.** The Assistant Superintendent of Support Services shall be provided with vacation days as provided in the document entitled Administrator and Administrative Support Staff Compensation and Benefits (October 8, 2024).

**19. Sick Leave and Personal Leave.** The Assistant Superintendent of Support Services shall be provided with sick leave and personal leave days as provided in the document

entitled Administrator and Administrative Support Staff Compensation and Benefits (October 8, 2024).

**20. Disability.** Should the Assistant Superintendent of Support Services be unable to perform the duties and obligations of this Contract, by reason of illness, accident or other cause beyond the Assistant Superintendent of Support Services' control and such disability exists after the exhaustion of accumulated leave days and vacation days during any school year, the Board, in its discretion, may make a proportionate deduction from the salary stipulated. If such disability continues for sixty (60) days after the exhaustion of accumulated leave days (including FMLA) and vacation days during any school year, or if such disability is permanent, irreparable or of such nature as to make the performance of the Assistant Superintendent of Support Services' duties impossible, the Board, at its option, may terminate this Contract, whereupon the respective duties, rights and obligations of the parties shall terminate. The Assistant Superintendent of Support Services shall provide medical evidence of illness to the Board President upon request.

**21. Criminal Records Check.** Pursuant to 105 ILCS 5/10-21.9, Boards of Education are prohibited from knowingly employing a person who has been convicted of committing or attempting to commit the named crimes therein. If the fingerprint-based criminal records check required by Illinois law is not completed at the time this Contract is signed, and any subsequent investigation or report reveals there has been such a conviction, this Contract shall immediately become null and void.

**22. Employment History Review.** Pursuant to 105 ILCS 5/22-94, the Assistant Superintendent of Support Services shall submit to employee history review, and shall execute and deliver to the Board of Education all necessary consent and forms necessary to accomplish such task. If the Assistant Superintendent of Support Services fails to disclose necessary information, fails to complete and deliver appropriate forms upon demand, or if a subsequent employment history review reveals there has been a report or investigation that did not result in an unfounded or fabricated result, this Contract shall immediately become null and void.

Contract Extension.** At the end of any year of this Contract, the Board and the Assistant Superintendent of Support Services may mutually agree to extend the employment of the Assistant Superintendent of Support Services for a multi-year period of up to five (5) years. In such event, the Board shall take specific action to discontinue this Contract and enter into a multi-year Contract of Employment as allowed by law. Notwithstanding the foregoing, prior to April 1 of the year in which this Contract expires, the Board shall take action to extend or not to extend the terms of this Contract for one additional year, and shall notify the Assistant Superintendent of Support Services in writing of such action. Failure of the Board to take such action shall extend this Contract for one (1) additional year.

**26. Copies of Contract.** This Contract may be executed in one or more counterparts, each of which shall be considered an original, and all of which taken together shall be considered one and the same instrument.

**27. Severability.** It is understood and agreed by the parties that if any part, term, or provision of this Contract is held by the courts to be illegal or in conflict with any law of the State of Illinois, the validity of remaining portions or provisions shall not be affected, and the rights and obligations of the parties shall be construed and enforced as if the Contract did not contain the particular part, term, or provision held to be invalid.

Evaluation.** Annually, but no later than March 1st of each year, the Assistant Superintendent or designee shall review with the Administrator's progress toward established goals and working relationships among the Superintendent, the District leadership team, other Directors, the faculty, the staff and the community, and shall consider the Administrator's annual salary for the next subsequent year (if any). A summary of the evaluation will be provided to the Accounting & Auditing Administrator in writing within 30 days following the evaluation, pursuant to the District's evaluation plan for Administrators.

**6. License.** The Accounting & Auditing Administrator shall furnish to the Board during the term of this Contract, a valid and appropriate license to act as Accounting & Auditing Administrator in accordance with the laws of the State of Illinois and as directed by the Board.

**7. Other Work.** Permission will be granted in advance by the Superintendent. The Accounting & Auditing Administrator may undertake consultative work, speaking engagements, writing, lecturing, college or university teaching, and other professional duties and obligations provided that these activities do not interfere with the effective performance of job duties. The Accounting & Auditing Administrator shall have the responsibility to discuss with the Superintendent and mutually agree to such outside activity in a timely fashion.

**8. Discharge for Good Cause.** Throughout the term of this Contract, the Accounting & Auditing Administrator shall be subject to discharge for good cause provided, however, that the Board shall not arbitrarily or capriciously call for dismissal and that the Accounting & Auditing Administrator shall have the right to service of written charges, notice of hearing and a hearing before the Board. If the Accounting & Auditing Administrator chooses to be accompanied by counsel at such a hearing, all such personal expenses shall be paid by the Administrator. Failure to comply with the terms and conditions of this Contract shall also be sufficient cause for purposes of discharge as provided in this Contract.

**9. Termination by Contract.** During the term of this Contract, the Board and Accounting & Auditing Administrator may mutually agree, in writing, to terminate this Contract. The termination and/or reclassification at the end of the term of this Contract shall be as provided by law.

**10. Referrals to Administrator.** The Board collectively and individually and the Superintendent shall promptly refer all criticisms, complaints, and suggestions called to its/their attention to the Accounting & Auditing Administrator for study and recommendation.

**11. Professional Activities.** The Accounting & Auditing Administrator shall be encouraged to attend appropriate professional meetings at the local, state, and national levels.

Within budget constraints, such costs of attendance shall be paid by the Board upon receipt of a full, itemized account of such costs.

**12. Reimbursement for Use of Personal Car.** The Board shall pay the Internal Revenue Service rate to the Accounting & Auditing Administrator for vouchered reimbursable mileage expenses incurred by the Accounting & Auditing Administrator while using the Administrator's personal vehicle for the conduct of approved District business. Reimbursement shall be pursuant to the District's policies, rules and regulations.

**13. Membership Dues.** The Board shall pay the cost of the Administrator's annual membership dues as provided in the document entitled Administrator and Administrative Support Staff Compensation and Benefits (October 8, 2024).

**14. Medical Insurance.** The Accounting & Auditing Administrator shall be provided with medical insurance and medical insurance options as provided in the document entitled Administrator and Administrative Support Staff Compensation and Benefits (October 8, 2024).

**15. Life Insurance.** The Accounting & Auditing Administrator shall be provided with life insurance as provided in the document entitled Administrator and Administrative Support Staff Compensation and Benefits (October 8, 2024).

**16. Vacation.** The Accounting & Auditing Administrator shall be provided with vacation days as provided in the document entitled Administrator and Administrative Support Staff Compensation and Benefits (October 8, 2024).

**17. Sick Leave and Personal Leave.** The Accounting & Auditing Administrator shall be provided with sick leave and personal leave days as provided in the document entitled Administrator and Administrative Support Staff Compensation and Benefits (October 8, 2024).

**18. Disability.** Should the Accounting & Auditing Administrator be unable to perform the duties and obligations of this Contract, by reason of illness, accident or other cause beyond the Administrator's control and such disability exists after the exhaustion of accumulated leave days and vacation days during any school year, the Board, in its discretion, may make a proportionate deduction from the salary stipulated. If such disability continues for sixty (60) days after the exhaustion of accumulated leave days (including FMLA) and vacation days during any school year, or if such disability is permanent, irreparable or of such nature as to make the performance of the Administrator's duties impossible, the Board, at its option, may terminate this Contract, whereupon the respective duties, rights and obligations of the parties shall terminate. The Accounting & Auditing Administrator shall provide medical evidence of illness to the Board President upon request.

**19. Criminal Records Check.** Pursuant to 105 ILCS 5/10-21.9, Boards of Education are prohibited from knowingly employing a person who has been convicted of committing or attempting to commit the named crimes therein. If the fingerprint-based criminal records check required by Illinois law is not completed at the time this Contract is signed, and any subsequent investigation or report reveals there has been such a conviction, this Contract shall immediately

become null and void.

**20. Employment History Review.** Pursuant to 105 ILCS 5/22-94, the Accounting & Auditing Administrator shall submit to an employee history review, and shall execute and deliver to the Board of Education all necessary consent and forms necessary to accomplish such task. If the Accounting & Auditing Administrator fails to disclose necessary information, fails to complete and deliver appropriate forms upon demand, or if a subsequent employment history review reveals there has been a report or investigation that did not result in an unfounded or fabricated result, this Contract shall immediately become null and void.

**21. Notice.** Any notice required under this Contract shall be in writing and shall become effective on the day of mailing thereof by first class, registered or certified mail, postage prepaid, addressed:

**22. Headings.** Paragraph headings and numbers have been inserted for convenience of reference only, and if there shall be any conflict between any such headings or numbers and the text of this Contract, the text shall control.

**23. Contract Extension.** At the end of any year of this Contract, the Board and Accounting & Auditing Administrator may mutually agree to extend the employment of the Accounting & Auditing Administrator for a multi-year period of up to five (5) years. In such event, the Board shall take specific action to discontinue this Contract and enter into a multi-year Contract of Employment as allowed by law. Notwithstanding the foregoing, prior to April 1 of the year in which this Contract expires, the Board shall take action to extend or not to extend the terms of this Contract for one additional year, and shall notify the Accounting & Auditing Administrator in writing of such action. Failure of the Board to take such action shall extend this Contract for one (1) additional year.

**24. Copies of Contract.** This Contract may be executed in one or more counterparts, each of which shall be considered an original, and all of which taken together shall be considered one and the same instrument.

**25. Severability.** It is understood and agreed by the parties that if any part, term, or provision of this Contract is held by the courts to be illegal or in conflict with any law of the State of Illinois, the validity of remaining portions or provisions shall not be affected, and the rights and obligations of the parties shall be construed and enforced as if the Contract did not contain the particular part, term, or provision held to be invalid.

**26. Jurisdiction.** This Contract has been executed in the State of Illinois, and shall be governed in accordance with the laws of the State of Illinois in every respect.

**CURRENT CONSIDERATIONS:**

District administration, in consultation with DEA leadership, has identified common priorities for allocating Teacher Vacancy Grant funds. These priorities include retaining certified staff by allocating three \$250 retention stipends to all staff under the DEA collective bargaining agreement who are currently active employees.

A \$250 stipend will be paid in December 2024, a second \$250 stipend will be paid in May 2025, and a third \$250 stipend will be paid in July 2025.







**BACKGROUND INFORMATION:**

Each fall the Board of Education approves a tentative tax levy not less than 20 days prior to adopting the levy in December. The final levy must be filed with Macon County before the last Tuesday in December. The Board approved the tentative estimated levy on November 12, 2024.

The District is required to hold a public hearing if the non-debt service levy is anticipated to increase by 5.0% or more over the prior year’s, non-debt service extension. Since the balloon levy request is an increase of 7.7% over the prior year, a public hearing is required. This year’s tax levy includes potential revenue from portions of the expiring Old Towne TIF.

**CURRENT CONSIDERATIONS:**

The final extension and related tax rate are contingent upon the District’s final Equalized Assessed Value (EAV). The Districts EAV will not be final until February 2025. Since the Preliminary Levy, the estimated EAV has reduced slightly and TIF and EZ Reductions are unknown. The restricted levy rates are ballooned (more funds requested than anticipated) to capture additional EAV increases that may occur after the levy is submitted.

Current legislation mandates annual disclosure of cash balances. School Code, Section 17-1.3 requires 'Disclosure of cash balance' mandating the annual disclosure of the school district's cash reserve balance of 'all funds held by the district related to its operational levy and, if applicable, any obligations secured by those funds'. This slide represents the audited beginning fund balance as of June 30, 2024.

**FINANCIAL CONSIDERATIONS:**

The annual levy provides one of the primary sources of revenues for the District. For operational funds, the District anticipates tax revenues of approximately \$37,000,000 – \$38,751,966.

DPS utilizes a proprietary access control system through our building automation systems to control entrance into the buildings to authorized people. The existing access CPU controllers are becoming antiquated and will soon be obsolete. The supply of replacement controllers is extremely limited as they are no longer manufactured.

The proprietary access control CPUs are provided by the District’s long-term vendor that maintains our building automation system, Entec Services, Inc. Entec Services has provided a quote for \$49,385.00 to provide the controllers and to perform their installation during the upcoming Christmas break.
