

**BACKGROUND INFORMATION:**

The Consolidated Election for the Board of Education was held this year on April 01, 2025. Outgoing candidates whose terms expired this year included four (4) members: Alana Banks, Kevin Collins, Jason Dion and Al Scheider.

Candidates, whose names appeared on the ballot (in this order) for these four (4) positions, were as follows: Karen Lauritzen, Jason Dion, Anthony “Tony” Albertina, Kevin R. Hale, Christina Tyus and Devon Martinez Joyner.

Jason Dion was the only incumbent that ran for the April 2025 election.

**CURRENT CONSIDERATIONS:**

On Tuesday, April 15, 2025, Josh Tanner, County Clerk of Macon County, certified the Abstract of Votes as he canvassed the returns of the Consolidated Election held on Tuesday, April 01, 2025. This certification was US mailed and received by Melissa Bradford, Board Secretary, on Monday, April 28, 2025.
